


Ottawa Showcase:


2018 Barriers V2



- 5. Engaging with Government Training (for successful applicants): half-day April 23
- 6. Showcase event in Ottawa May 8th

Venture Selection Process

- CRIN will seek to select representative innovator companies across a diverse set of **low carbon** emissions innovation pathways **relevant to oil and gas**.
- Companies must have **validation** from a major oil and gas company, industry partner or investor
- CRIN will strive in its selection to reflect **diverse**, inclusive and Pan-Canadian perspectives
- SC will make final decision based on subjective scoring on the points above
